CITY ELECTION AND OFFICES UP FOR ELECTION 2010

- 1) **GALLATIN:** MAYOR, CITY RECORDER, 1 ALDERMAN AT LARGE, & 3 ALDERMEN 1 FROM DISTRICT 3, DISTRICT 4 AND DISTRICT 5 FOR 4 YEAR TERMS EACH
- 2) **GOODLETTSVILLE CITY:** 2 CITY COMMISSIONERS AT LARGE FOR 4 YEAR TERMS EACH ** ELECTION HELD BY DAVIDSON COUNTY BUT WILL BE ON BALLOT IN SUMNER AND DAVIDSON COUNTY
- 3) **HENDERSONVILLE:** 6 ALDERMEN 1 FROM EACH WARD FOR 4 YEAR TERMS EACH
- 4) **MITCHELLVILLE:** MAYOR AND 3 ALDERMEN AT LARGE FOR 4 YEAR TERMS EACH

- 5) **WESTMORELAND:** MAYOR AND 2 ALDERMEN AT LARGE FOR FOUR YEAR TERMS EACH

- 6) **WHITE HOUSE:** MAYOR, 1 ALDERMAN FROM WARD 1 ROBERTSON COUNTY AND 1 ALDERMAN FROM WARD 2 SUMNER COUNTY FOR 4 YEAR TERMS EACH
